TERMS

This agreement is executed on the registration date shown above, by and between Everest World Class TaeKwonDo, its successors, staff, assigns and those acting under its authority, herein referred to as the Academy, the Buyer, who's signature is affixed hereto, herein known as the Buyer and each Student listed above, herein referred to as the Student for the purposes of attending Everest World Class Children's Spring Break Martial Arts Camp. The Academy reserves the right to revoke this Agreement at any time.

Attendance: The Academy agrees to provide martial art instruction to each Student during the period schedule above, The Buyer and each Student understands that the it is the responsibility of each Student to attend Classes. The Buyer understands that the entire Balance Due is payable according to this agreement, regardless of whether or not the Student attends Classes provided by the Academy.

Emergency Release: Buyer consents to allow the Academy to take such actions as is deemed necessary to contact and provide emergency and medical assistance for Student.

Liability: Buyer, hereby acknowledges the strenuous physical exercise involved in the participation of Classes given by the Academy and that the Student attends Classes at their own risk. Buyer hereby consents to hold the Academy, staff and assigns free of any and all liability, claims, or actions whatsoever, arising from any injuries, accidents, illness, etc., due to the Student's attendance at Classes.

Media: I, the undersigned Buyer, irrevocably authorize the Academy to copyright, use, publish for art, advertising, trade or any other lawful purpose whatsoever, photographic portraits, pictures and videotapes of the Student and/or Buyer, included in whole or in part.

Financial Remedies: The Buyer acknowledges and agrees to the following financial remedies:

- 1. All Camp fees must be paid in full on the Friday prior to the first day of Camp or a late fee of \$20.00 will be assessed for the first three (3) business days and \$5.00 each day thereafter until full payment is received.
- 2. A \$20 fee will be accessed for any check returned or debit/credit payment declined.
- 3. A \$5.00 fee will be assessed for every 15 minutes past the 6:30 PM pick-up time per Student listed above in this Agreement.

Force Majeure: The Academy is not liable for failure to perform the party's obligations if such failure is as a result of Acts of God, including, but not limited to: fire, flood, earthquake, storm, hurricane or other natural disaster, government intervention, embargo, labor dispute, or failure of electricity or telephone service, etc.

Severability: If a provision of this Agreement is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this Agreement.

Consumers' Right of Cancellation: Buyer may cancel Agreement penalty free within 3 days of registration date, exclusive of holidays and weekends, upon mailing or delivering a written, certified notice of cancellation to the Academy. However, Buyer's right of cancellation is expressly waived once a Student has engaged in Classes, or made use of the facility or equipment provided by the Academy.
